Our entire state delegation made it back to Oconee just in time for the meeting and provided updates on what's happening in Columbia at both the SC State House and Senate. I greatly appreciated them extending their day and hustling back to spend the evening with us.

In total, we had 17 candidates in attendance from up & down the ballot, including representatives from both the Haley and Trump campaigns. We found out that Pine St. has been a beenive of activity for early voting in the SC Republican Presidential Primary, with votes on the 1st day of the Republican Presidential Primary outnumbering the total votes cast in the county for the Democratic Presidential Primary. It does make you wonder how many Dems waited until the GOP primary to vote?? Below are some key dates to remember:

- 2/12 Early voting starts GOP Presidential Primary
- 2/24 Election Day GOP Presidential Primary
- 3/16 Candidate filing opens (noon)
- 4/1 Candidate filing closes (noon)
- 4/5 Candidate certification (noon)
- 5/28 Early voting starts
- 6/7 Early voting ends
- 6/11 Election day statewide GOP primary
